## **OUR SCHOOL PLEDGE**

I promise to carry myself with pride and dignity; to treat all members of the Lake George Charter School with courtesy and respect; to uphold the honor of my family, my school, and my community in all my undertakings. I am proud to be a student of the Lake George Charter School. I accept the status, privileges, honor, and responsibilities of membership in the Lake George Charter School.

## **THE SCHOOL DAY**

We will begin serving breakfast at 7:30 when the front doors open and stop serving at exactly 8:00 when the front doors lock down. Our day officially begins at 7:55. Attendance and lunch count will be taken before entering the gym. At morning meeting, we recite the Pledge of Allegiance and our School Pledge. Students will be dismissed with their class after morning meeting is over. Parents are asked not to walk with their student to their classroom.

## **ATTENDANCE**

Colorado State Statute requires all students to have regular school attendance. We cannot do our job if your child is absent. A child who misses a day of school also misses a day of learning that might never be replaced. You can help by making school a top priority. By building the habit of daily attendance, you will help your child see that school is important. Even though students may make up missed assignments at home, they miss the class discussion and integration of classroom objectives, which is critical to the overall learning process. Of course, we do not want ill students to attend school, but we certainly encourage avoiding absences due to other circumstances.

If your child is going to be absent, it is of utmost importance that the office is notified at 748-3911 before 8:00 on the morning of the absence. The procedure for receiving daily assignments for students who are absent is as follows:

1. A request, by telephone or note, should be made to the office by 10:00am.
2. The homework may be picked up at the end of the day in the office, giving teachers ample time to prepare it.

Excessive tardies (more than 5 per quarter) will result in forfeiture of potential attendance awards. Students arriving more than two hours late or leaving more than two hours before school is dismissed will be considered absent that half of the day. Please schedule appointments on Friday whenever possible to avoid having your child miss school.

## **SCHOOL CLOSINGS/DELAYS**

Decisions regarding delays and canceling school will be made by 5:30 am and posted on our school website ([www.lakegeorgecharterschool.com](http://www.lakegeorgecharterschool.com)), and on Colorado Springs news stations. We will use Alma, our student information system, and, you may also sign up to get notices from Flash Alert, at [www.FlashAlert.net/id/LakeGeorgeCharterSchool](http://www.FlashAlert.net/id/LakeGeorgeCharterSchool). These will include school closures and delays.

## **PICKUP AND DROP OFF**

There are a large number of cars entering our driveway in the mornings and afternoons. Please drive slowly and watch for children as you approach the school. If you need to exit your car when either dropping your children off in the morning or picking them up in the afternoon, please park in a parking space and walk over to the school. You may sign your student out for early dismissal up to 3:45, after this time you are requested to wait outside to the side of the front doors to the school. When using the driveway in front of the school, stay in your car and pull forward whenever possible.

**When dropping off preschool students in the morning or at noon:** Parents/Guardians may park in the preschool area marked by the green curb. This is 5 minute parking, so please return to your vehicle as soon as possible. Pre-school parents may still enter the building to collect their students.

Students will be dismissed from their classes to parents' vehicles. Families will be assigned unique identification numbers to display in their windshield upon entering the pick-up lane. We will provide you with two copies at the beginning of the school year. We aim to make our pick-up procedures efficient and safe in situations where staff does not recognize personal vehicles and we can easily identify your family number.

If your student is tardy or you need to pick them up early, please sign them in/out in the foyer. Waiting for your child in the foyer helps us to monitor hallways. In the interest of respecting students' quiet learning environment and monitoring safety, staff members are vigilant about knowing if there are additional people in the hallway past the gymnasium.

Preschool parents who are picking up their students will be allowed to meet the class to pick up and sign out their children 5 minutes before the end of the school day, but not before. This is to provide all classes a quiet learning environment.

## **RECESS AND DAILY FITNESS**

Students need regular aerobic activity to be their best both physically and academically at school. We have two recess periods scheduled into our day – one at lunchtime and one mid-afternoon. In addition to this, each class will have a structured fitness activity every morning. Children should be dressed appropriately to participate fully in all of these activities. Please ensure your child wears shoes appropriate for walking or running. Recess will be outside unless the temperature and/or wind chill is below 20 degrees or it is raining or snowing.

## **PLAYGROUND RULES**

Classroom teachers will review proper use of the playground equipment during the first week of school. Violating these rules will result in loss of recess time by sitting out on the bench. Students are not allowed on the playground before or after school unless they are accompanied by an adult.

## **FOOD SERVICE**

All Colorado school districts, including the state's 10 largest, plan to offer free meals to all students this year through a new state program approved by voters last November 2022.

The new program, funded with a tax on high earners, will make Colorado one of only a handful of states to offer free school meals to all students, a move advocates say will feed more hungry kids and take away the stigma currently associated with receiving free school meals.

Adults are welcome to join us for breakfast or lunch, at the cost of \$2 for breakfast, and \$3.50 for lunch. Adults should call ahead, by 8:30 am, to order lunch.

## **HOMEWORK**

On occasion, students may need to spend some time on homework, to catch up, or if the teacher deems it beneficial to the student. Please check your student's planner every day. If you have questions or concerns, please contact your child's teacher.

## **MEDICINE**

Students are not to be in direct possession of any prescription or nonprescription medication. All medication shall be safeguarded in the office and dispensed only with a doctor's note and by school personnel trained and delegated to the task of giving such medication. Medications must remain in their original container and have your students name on it. This includes over the counter medications and even cough drops.

## **DRESS CODE**

The dress code at LGCS is intended to support a safe, respectful, and positive learning environment. In general, all clothing should be appropriate to the student's age, the school setting, and the weather. We do not allow clothing which promotes alcohol, drugs, weapons, gang affiliation, profanity, or is sexually suggestive. Nor do we allow clothing which exposes traditionally private parts of the body or threatens the safety of students. If a student is found to be out of compliance then the student will be given attire that is appropriate and referred to our discipline procedures.

The following items are not allowed at school or at school activities:

- short skirts/shorts
- halter tops
- tops with straps less than 1.5 inches wide
- flip-flops
- muscle tops
- low cut tops
- sagging pants
- makeup (elementary)
- sunglasses or hats inside the building

## **MEDIA DEVICES**

Students are not to have cell phones, electronic games, cameras, or music devices at school. Neither staff nor students will be interrupted during class time for phone calls except in the event of an emergency. Students may not use the phone for any reason without permission. Students found with electronic devices can turn them in voluntarily to the Front Office for safekeeping until school dismisses.

## **CLASSROOM VISITATION**

If parents/guardians would like to visit their child's classrooms for one period or less (up to one hour) then arrangements with that classroom teacher will need to be made in advance. If the parent/ guardian is seeking a longer visitation in the classroom or on school grounds other than the cafeteria then arrangements with the administrator will need to be made in advance.

## **LION'S PRIDE**

A vital part of our school is our parent/staff organization. Lion's Pride organizes events and fundraisers throughout the year. These activities help support individual student needs, field trips, and other wonderful aspects of our school program which make Lake George Charter School so special. All of our parents/guardians belong to Lion's Pride. There are no dues for membership. Please watch for meeting times and join us to see how you can help support your school.

## **REPORT CARDS**

Our curriculum is based on Colorado State Academic Standards. Grades reflect not only the mastery of skills, but also the completion of all assignments. Grading is based upon the following:

### Grades K-12

- A 90-100%
- B 80-90%
- C 70-80%
- D 60-70%
- F Below 60%
- I-Incomplete

There will be an Honor Roll which students in grades 3-8 can work towards. Attendance Awards will be given to students with no absences and no more than 5 tardys in a semester.

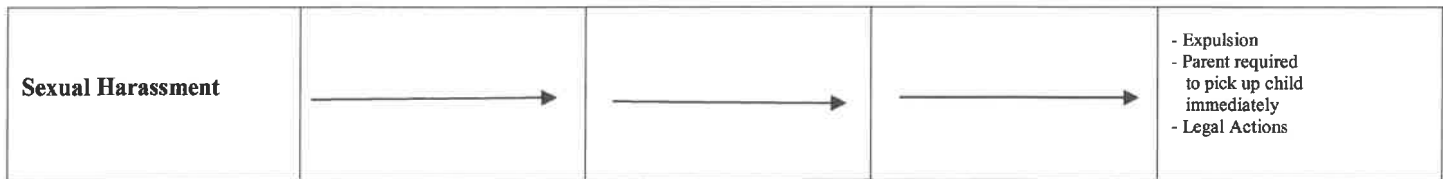

# Playground Rules

**Students are expected to be safe, respectable, kind and responsible.**

## **In general:**

No saving equipment for other students.

If others are waiting, students need to limit turns to a reasonable amount of time.

Stay 3' away from equipment while waiting for a turn.

Students are to line up immediately when the whistle is blown.

Students are expected to stay in sight of playground teachers.

Students need to stay off the ice for their own safety.

Rocks and snow must stay on the ground.

Students are not allowed on the playground before or after school unless they are accompanied by an adult.

## **Swings:**

- a. Only one person in a swing at a time.
- b. No jumping off swings, standing in swings, twisting the chains, sideways swinging, kicking or under ducks.

## **Slide:**

- a. No jumping off the slide.
- b. Students should be seated and go down feet first.
- c. Thursday is "UP" day. Students are allowed to go up the slide but not back down.

## **Glider:**

- a. Only one person on the glider at a time.
- b. Only two people at a time on the step.
- c. Do not return the glider with excessive force.
- d. Students will hang with two hands and ride with feet down.

## **Sit and Spin:**

- a. Only one person at a time.
- b. No standing.

## **Dizzy Tron:**

- a. No more than 2 students at a time with one person spinning.
- b. Riders should hold on with both hands.

**Whirl around:**

- a. No more than 3 riders at a time.
- b. Riders may not let go while spinning.

**Rope Course:**

- a. No more than 6 students on the rope structure at a time.
- b. No pushing, shaking the ropes or pulling other students off the ropes.

**Soccer Goals:**

- a. No climbing or hanging on the nets.

**Balls:**

- a. No kicking, hitting or bouncing balls against any wall.
- b. If balls go over the fence, they will be retrieved at the end of recess.
- c. If balls go on the roof, they will be retrieved at a later time.

**Snow Saucers:**

- a. Only one student pulling and one riding at a time on the field.

**New Structure:**

- a. No jumping off structure.
- b. The two slides that face the west are very steep. Only go down these slides.
- c. Only sit on the spiral, no standing.

**Personal Contact:**

- a. Students may not restrict or stop other student's movements.
- b. No grabbing, hitting, pushing, kicking or wrestling.

**Toys:**

- a. Students may bring small toys of their own onto the playground for afternoon recess, but they must be responsible for them.
- b. No skateboards, roller blades, wheelies or skates.

## Student Dress Code

A safe and disciplined learning environment is essential to a quality educational program. School-wide standards on student attire are intended to help students concentrate on schoolwork, reduce discipline problems, and improve school order and safety. The Charter Board recognizes that students have a right to express themselves through dress and personal appearance; however, students shall not wear apparel that is deemed disruptive or potentially disruptive to the classroom environment or to the maintenance of a safe and orderly school.

Any student deemed in violation of the dress code shall be required to change into appropriate clothing or make arrangements to have appropriate clothing brought to school immediately. In this case, there shall be no further penalty.

If the student cannot promptly obtain appropriate clothing, the student shall be given a reminder and an administrator shall notify the student's parents/guardians.

### Unacceptable Items

The following items are not acceptable in school buildings, on school grounds, or at school activities:

1. Shorts, dresses, skirts, or other similar clothing shorter than mid-thigh length.
2. Sunglasses and/or hats worn inside the building.
3. Inappropriately sheer, tight, or low-cut clothing (e.g., midriffs, halter tops, backless clothing, tube tops, garments made of fishnet, mesh, or similar material, muscle tops, etc.) that bare or expose traditionally private parts of the body including, but not limited to, the stomach, buttocks, back, and breasts.
4. Tank tops or other similar clothing with straps narrower than 1.5 inches in width.
5. Any clothing, paraphernalia, grooming, jewelry, hair coloring, accessories, or body adornments that are or contain any advertisement, symbols, words, slogans, patches, or pictures that:
  - Refer to drugs, tobacco, alcohol, or weapons
  - Are of a sexual nature
  - By virtue of color, arrangement, trademark, or other attribute denote membership in gangs which advocate drug use, violence, or disruptive behavior
  - Are obscene, profane, vulgar, lewd, or legally libelous
  - Threaten the safety or welfare of any person
  - Promote any activity prohibited by the student code of conduct
  - Otherwise disrupt the teaching-learning process
6. Make-up must not be worn to school. Face painting, costume make-up, etc. can be used on specific events that are set aside for that, such as Halloween parties. During those specific events, the costume make-up or face-painting must not be offensive.
7. Hairstyles are the jurisdiction of the individual student. However, if an offensive symbol is shaved into a student's scalp, the student will not be allowed to come on the campus.

Any areas that are not covered in the policy and raise the concern of staff members, will be addressed by meeting with the student, administrator, and parent (if necessary) to determine as a team whether or not the dress is appropriate.

## Exceptions

Appropriate athletic clothing may be worn in physical education classes. Clothing normally worn when participating in school-sponsored extra curricular or sports activities (such as cheerleading uniforms and the like) may be worn to school when approved by the sponsor or coach.

The administrator, in conjunction with the school accountability committee, may develop and adopt school-specific dress codes that are consistent with this policy.

## SEXUAL HARASSMENT

Sexual harassment is recognized as a form of sex discrimination and thus a violation of the laws which prohibit sex discrimination.

A learning environment that is free from sexual harassment shall be maintained. It shall be a violation of policy for any staff member to harass students, for students to harass other students, or for a student to harass a staff member, through conduct or communications of a sexual nature.

Unwelcome sexual advances, requests for sexual favors, or other verbal or physical conduct of a sexual nature may constitute sexual harassment when:

1. Submission to such conduct is made either explicitly or implicitly a term or condition of a person's educational development or safety.
2. Submission to or rejection of such conduct by an individual is used as the basis for education decisions affecting such individual.
3. Such conduct has the purpose or effect of unreasonably interfering with an individual's educational performance or creating an intimidating, hostile or offensive educational environment.

Sexual harassment as defined above may include but is not limited to:

1. Sex-oriented verbal "kidding," abuse or harassment
2. Pressure for sexual activity
3. Repeated remarks to a person with sexual or demeaning implications
4. Unwelcome touching, such as patting, pinching or constant brushing against another's body
5. Suggesting or demanding sexual involvement, accompanied by implied or explicit threats concerning one's grades or similar personal concerns

Students may file a formal grievance of sexual harassment through use of the accompanying grievance procedure. If the alleged harasser is the administrator with whom a grievance routinely would be filed, the student may file the grievance with an alternate staff member.

All matters involving sexual harassment complaints shall remain confidential to the extent possible.

Filing of a grievance or otherwise reporting sexual harassment shall not reflect upon the individual's status or affect grades.

Notice of this policy shall be circulated throughout the charter school and incorporated in student handbooks.

Define 'educational environment': Any area, physical or virtual, that is associated with any school activity or function.
